

# Memorandum of Understanding



## FISU Recognised Sports

## Between the undersigned:

 INTERNATIONAL UNIVERSITY SPORTS FEDERATION represented by Mr. Oleg Matytsin, President (hereafter called FISU)

on the one hand, and

THE WORLD UNDERWATER FEDERATION represented by Ms. Anna Arzhanova, President (hereafter called CMAS)

It has been agreed as follows:

## Article 1 - PRINCIPLES OF COLLABORATION

- 1.1 FISU recognises the interest in Finswimming and invites its members, the National University Sport Federations (NUSFs), to consider Finswimming and its National Governing Bodies as a partner for the development of FISU and the interests of the University Sport movement.
- 1.2 FISU and CMAS have decided to carry out Initiatives to:
  - Encourage the development of the practice of Finswimming by university students of both genders:
  - b. Further encourage gender equity in the practice of University Sport;
  - Promote sustainability, the concepts of fair-play and integrity, and join the fight against all forms of racism in sport.

## Article 2 - OPERATING PRINCIPLES

2.1 The CMAS shall invite a member of the FISU Executive Committee or his/her representative to their International University event, may FISU endorse it.

## Article 3 - COMPETITION

3.1 FISU organises international sports competitions for student-athletes: the FISU Summer Universiade, the FISU Winter Universiade, the FISU World University Championships and the FISU University World Cups - CMAS oversees the organisation of international Finswimmlng competitions.



## Memorandum of Understanding

CMAS

- CMAS may organise International University Finswimming events endorsed by FISU following the "Regulations for FISU Endorsed Events" such as:
  - a Participants eligibility;
  - b Event responsibility (FISU will take no responsibility for its organisation);
  - FISU visibility;
  - d Invitation of a FISU representative;
  - Report to FISU.

#### Article 4 - PROMOTION

- 4.1 FISU and CMAS undertake to:
  - a Promote each other's activities and help establish the connection between respective national member federations - university sport and Finswimming. Foster the cooperation with and collaboration between these members;
  - b. Make their collaboration known through the means available to them;
  - c. Actively communicate regarding the FISU and CMAS collaboration in respective publications and other media; and
  - d. Establish a permanent link between websites.

#### Article 5 - IMPLEMENTATION

**S 1** FISU and CMAS undertake to fully apply the provisions of this convention with their respective member federations.

## Article 6-TERMINATION

This convention may be terminated by either party, particularly in the case of non-observance of the provisions stipulated herein. Termination will be done in writing with 3 months' notice.
